We are the proprietors of all copyright of digital content (audio, video, pdf) files entitled "Sermons of Bishop Lefebvre" (The "Work"). We have reserved all rights in the Work.

The site also contains very obscene material and slander against the priests of the Society of Saint Pius X and the Pope in Vatican.

This site was banished on 8th March 2011 by Site5 LLC (www.site5.com) in the USA and has shifted to Russia

in the past 24h and is correctly operating through your company's servers in violation of Russian, European

Union and Swiss laws.

This site contains very serious copyright violations and is unlawfully publishing content owned by our organization under the following URLs

http://catholicapedia.net

http://catholicapedia.info

We also inform you about obscene and very vulgar defamation contained in the following URLs in French language against the priests of the Society of Saint Pius X together with photomontage using photos belonging to the Society of Saint Pius X.

The account holder's multiple copyright violations were stopped by Softlayer, Site 5 in the USA, Servage GmbH in Germany and Piradius in Malaysia. Other sites owned by them on

virgo-maria.org, virgomaria.net, mgrlefebvre.info, mgrlefebvre.org and mgrlefebvre.net are still banished as you can check by yourself.

Permission was neither asked nor granted to the account holder to reproduce our work and these websites constitute an infringement of our rights as well as an outright theft of our proprietary content.

We have a good faith belief that use of the copyrighted materials described above as allegedly infringing is not authorized by the copyright owner, its agent, or the law.

I swear, under penalty of perjury, that the information in the notification is accurate and that the Society of Saint Pius X is the copyright owner and I am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

In terms of the Copyright Statutes, we are entitled to an injunction against your company for continued hosting of this stolen content on your servers, as well as to recover damages from you for the loss we have suffered as a result of this hosting.

In the circumstances, we demand that you immediately block acces to http://catholicapedia.net and http://catholicapedia.info till the copyright violations and the publication of defamatory articles are fully stopped.

We request notification to us in writing that you have taken all steps to ensure that websites http://catholicapedia.net and http://catholicapedia.info are put offline till the owner of the blog undertakes not to violate the law, post agressive and defamatory content against the Society of Saint Pius X or the terms of the service agreement with your company.

We await to hear from you by no later than close of business on 12th March 2011. This is written without prejudice to our rights, all of which are hereby expressly reserved.
